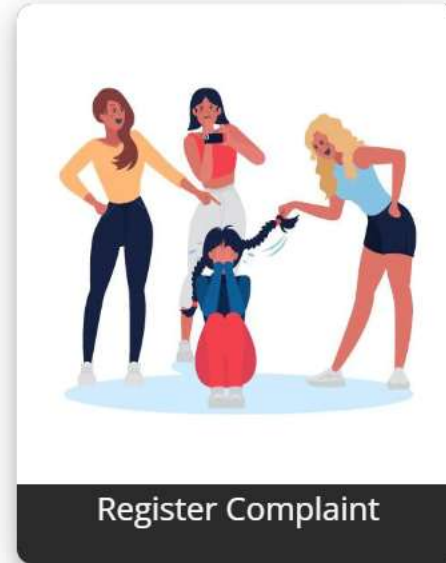


HOW TO FILL UP ANTIRAGGING UNDERTAKING

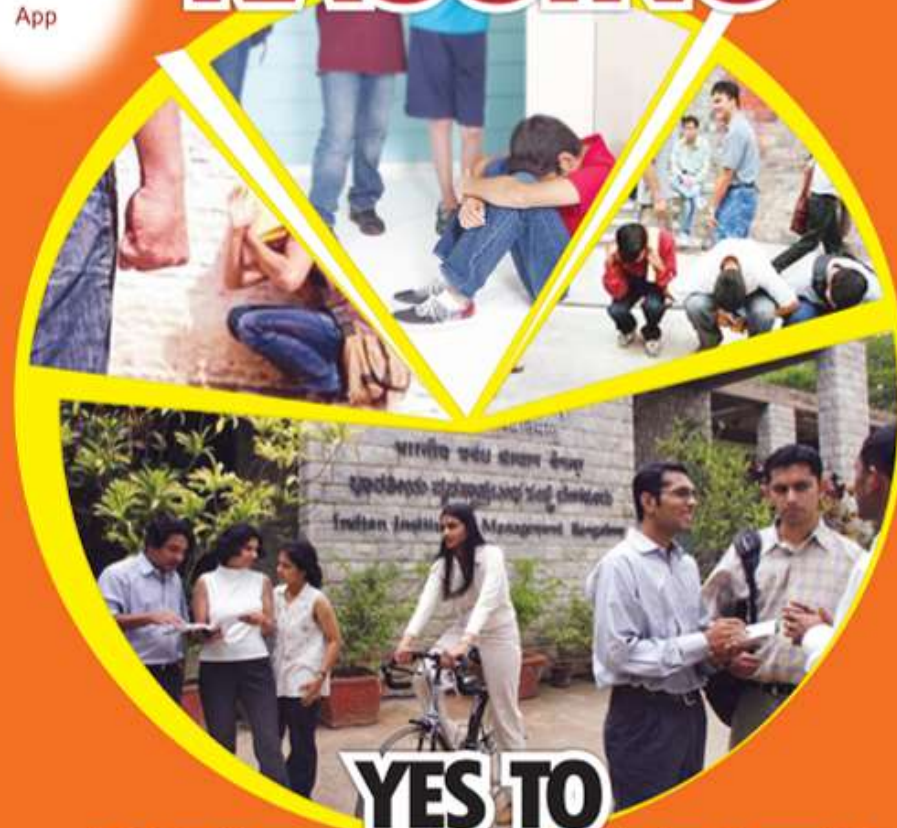
